ORDINANCE NO.

AN ORDINANCE PROVIDING FOR THE HOLDING OF THE GENERAL ELECTION FOR THE YEAR 2015 FOR THE CITY OF WARSON WOODS, MISSOURI, SETTING THE DATE FOR SAID ELECTION AND THE TIME THAT THE POLLS SHALL BE OPEN; SETTING THE RULES AND REGULATIONS BY WHICH THE ELECTION SHALL BE CONDUCTED; ENUMERATING THE ELECTIVE OFFICERS TO BE ELECTED AT SAID ELECTION; PROVIDING THE PUBLICATION OF THE NOTICE OF ELECTION AND THE EFFECTIVE DATE OF THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARSON WOODS, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

SECTION 1. That the General Election for the year 2015 for the City of Warson Woods, St. Louis County, Missouri, shall be held on the first Tuesday following the first Monday in April 2015; to-wit on April 7, 2015, in all of the Wards of the City and at the polling places shall be open at 6:00 A.M. and shall remain open until 7:00 P.M., on said date. Said Election shall be held and conducted under the provisions of Laws and Ordinances and Rules and Regulations of the Board of Election Commissioners of St. Louis County, Missouri.

SECTION 2. That the officers to be elected at said election shall be as follows:

One (1) Alderman from Ward 1—Two-Year Term
One (1) Alderman from Ward 2—Two-Year Term
One (1) Alderman from Ward 3—Two-Year Term
One (1) Alderman from Ward 4—Two-Year Term

All of said Aldermen shall be elected at said election by votes cast in the Ward in which they are candidates.

The Person receiving the highest number of votes cast for elected office for which that person is a candidate shall be declared elected to such office.

SECTION 3. Notice of said election shall be given by publication in a newspaper of general circulation, as designated by Missouri State Statutes, by the Board of Election Commissioners of St. Louis County, once a week for two consecutive weeks, the first publication occurring at least fourteen (14) days prior to the election and the last publication occurring within (1) week prior to the election, in substantially the following form:

“NOTICE IS HEREBY GIVEN THAT PURSUANT TO THE STATUTES OF THE STATE OF MISSOURI, AND ORDINANCE NO.1545 OF THE CITY OF WARSON WOODS, MISSOURI, ADOPTED BY THE BOARD OF ALDERMEN OF THE CITY OF WARSON WOODS, ON NOVEMBER 18, 2014, THE GENERAL ELECTION FOR THE SELECTION OF ONE (1) MAYOR AND ONE (1) ALDERMAN FROM EACH OF THE CITY’S FOUR (4) WARDS. GENERAL ELECTION SHALL BE HELD ON TUESDAY THE 7th DAY OF APRIL, 2015. SAID ELECTION SHALL BE HELD IN POLLING PLACES ESTABLISHED BY THE BOARD OF ELECTION COMMISSIONERS OF ST. LOUIS COUNTY, MISSOURI. POLLS SHALL REMAIN OPEN ON SAID DAY FROM 6:00 A.M. TO 7:00 P.M.”

SECTION 4. This ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approved by the Mayor.
