MISC. REPORTS

COLLECTOR—No report.

BUILDING COMMISSIONER—Dan Wilson reported that lately there have been three fences installed without permits. One went to the Board of Adjustment with the outcome being the owner has to remove the nonconforming portion. Two others he is still working with to resolve. One the owner said they are having the contractor fix the nonconforming portion at their own expense. The other he is still working with the owner. As he was leaving the last property he happened to come upon another fence project that did not have a permit. This one he stopped the project until the contractor obtained a permit. Next he mentioned that lately he has had several phone calls from prospective buyers asking proactive questions about remodeling and water drainage.

PARK COMMISSIONER (ACTING)—Gordon Gosh, submitted the attached report.

TENNIS COMMISSIONER—Mark Boland resigned because he moved out of Warson Woods.

CITY ENGINEER (ACTING)—Mike Dell'Orco informed everyone that 2017 Street work has been completed along with the joint sealing. He expects the final invoice any time. Next he mentioned that MoDOT has been in contact with him regarding their plans on refurbishing Manchester Rd. from Lindbergh to Big Bend Rd. They are focusing on the right-of-way by installing handicapped access sidewalks. Warson Woods does not have a jurisdiction in the area they are going to work on.

CITY ATTORNEY—Paul Rost stated that the Audits of AT&T and Verizon have shown less revenue each year. Later on the agenda there is a resolution to enter into a Tolling Agreement Granting Further Authority.

TREASURER—Jim Malik began by saying that most of the demo cost for St. Matts was on the October Treasurers report, \$91,617.00. Next he said that December 31st will be the first half of the fiscal year. He will have a ½ year analyses at the January meeting. He then mentioned that he will be putting together a multi-year sales tax report.

MAYOR—Larry Howe had no report at this time.

Chief Stanczak informed everyone that the Antique Mall was broken into on December 12th and approximately \$50,000.00 worth of merchandise was taken. They broke into the side emergency door. The Police response time was 22 seconds but the alarm company did not call the alarm in for 10 minutes. The police department has video of this person on several cameras.
