COLLECTOR—Kathy Mahany, nothing to report.

BUILDING COMMISSIONER—Dan Wilson reported that the Dollar Tree has replaced the oversized sign and it was done in a timely manner. Next he said he has not heard back from Dierberg's regarding their request to operate a smoker on the parking lot. At this time Alderman Wittich stated he went to the Dierberg's in West County and he noticed the smoker at that location is not a portable but rather a permanent structure. At this time Mayor Howe asked Mr. Wilson for a dollar amount of residential improvements made during this past year. Lastly the Mayor asked Mr. Wilson how the two projects Mr. Dunavant has are progressing. Mr. Wilson said the house on Flanders is almost totally under roof and the forest View house is moving along very well. Alderman Gosh stated he met with Mr. Wilson and several neighbors at the Forest View location home to discuss a tree and he noted that all the neighbors are getting along very well with this project.

PARK COMMISSIONER—Gordon Gosh submitted the attached report. He also stated that the playground equipment at Dreher Park had been vandalized but Steve put the equipment back together again. Alderman Andrews asked what happened. Mr. Gosh said someone, most likely kids, kicked the Little Tykes climbing cube pieces apart.

CITY ENGINEER—Ken Lichtenheld, stated that the contractor borrowed one of the Cities signs during the construction and it was damaged. The contractor said he would replace it but it still has not been replaced. Mr. Lichtenheld said he will call the contractor and ask about it again. Alderman Dell'Orco asked where the sealing was done. Mr. Lichtenheld said in Ward 4.

#### REGULAR BOARD MEETING—November 15, 2011

MAYOR— Larry Howe, discussed several items. First he asked the Board if the would like to hold another employee appreciation lunch. With the consensus being yes, it was decided to pick a date after the Thanksgiving holiday. He then stated that he received two prices for a salt spreader for the dump truck. After a discussion it was decided to ask the two dealers to submit a sealed bid for the spreader with a delivery date. Next he discussed the e-mail he sent to everyone summarizing the salting project and his assumption of the savings it would create. He then asked if the Solid Waste bid package had been prepared. The City Clerk answered yes that she, Alderman Wittich and the City Attorney had prepared the bid package and she will advertise for bids in December with the bids due back by January 10<sup>th</sup>. It will be included on the January agenda. The next item for discussion was a holiday party. Mayor Howe asked the Board if they would like to have a holiday party after the December Board meeting. The Board unanimously answered yes. Mayor Howe reminded everyone that candidate filing begins on Tuesday, December 13<sup>th</sup> 2011 at 8:00 a.m. and will end on Tuesday January 17<sup>th</sup> 2012 at 5:00 p.m. Up for election in 2012 are Alderwoman Pohl, Alderman Thompson, Alderman Bruenning, Alderman Dell'Orco and Mayor Howe. At this time Mayor Howe brought up installing a waterline at the Public Works garage. He said that he would still like to see this project completed. He then informed the Board that Steve Arterbury has completed a safety class for OSHA requirements for chemical spills. He then invited everyone to attend the City Clerks Holiday party, December 15, 2011 at Westborough Country Club. Lastly he thanked everyone who was involved with the clean up in the park after the last Cardinals baseball game.
