MINUTES

REGULAR BOARD MEETING—June 17, 2008

TREASURER'S REPORT—June 2008

The Treasurer explained that there were several expensive repairs. After a short discussion, On Voice Vote, the motion was unanimously approved.

BILLS AND RECURRING DISBURSEMENTS TO BE APPROVED

Alderwoman Pohl moved, seconded by Alderman Wittich, that the Bills with the Addendum be approved as submitted. On Voice Vote, the motion was unanimously approved.

GLENDALE FIRE REPORT— Alderman Gosh questioned the "power line down". The Police Chief said he was not sure what that was referring to possibly from the wind. It was not from an auto accident.

WARSON WOODS POLICE REPORT— No action required.

PETITIONS, REQUESTS AND COMPLAINTS- Dave Shilling, 1665 Calais Ct. discussed the 6% increase in the new Veolia Solid Waste Contract. He stated that the once per week pick-up was not a "good deal". He was disturbed by the fact that Veolia did not sent out a letter regarding the changes but he was thankful that the City explained them in the newsletter. The Board asked if it was known how many residents have opted for the one time per week solid waste pick up but was informed the City does not have these figures to date.

COLLECTOR—Kathy Mahany, absent.

BUILDING COMMISSIONER—Elijah Cunningham reported that 3 permits were issued during the month. There was one denial for a fence at 1621 Andrew. The resident has since modified the request and a permit was issued.

PARK COMMISSIONER—Gerry Murphy stated there has been a lot of activity at the facilities and Gamma still needs to complete the work cleaning out the creek.

CITY ENGINEER—Ken Lichtenheld reported on several items. First he believes the Benz/Parks contract has been completed. Regarding the sink hole on Flanders, the owner has been contacted by MSD. Next he discussed the fence work in the Park, the problems with the fire pit and other water issued in the park and pool area. The Board then discussed holding a Public Works meeting regarding the pool issues. He went on to discuss placing boulders along Warson Woods Dr. and the sidewalks on Flanders and Garland and the re paving behind 601 Flanders. After lengthy discussion on these issues, Alderman Wittich moved, seconded by Alderman Andrews to approve the following items;
