WHEREAS, the parties desire to extend the Agreement by a year until March 31, 2021; and

WHEREAS, this Second Amendment has been or will be approved by the Mayor and a majority of the Board of Aldermen of Warson Woods and by the Mayor and a majority of the Board of Aldermen of Glendale.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARSON WOODS, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

SECTION 1. The Board of Aldermen approves, and the Mayor is authorized to execute, and the Second Amendment to the Fire Protection and Law Enforcement Services Agreement with the City of Glendale in substantially the form attached hereto as Exhibit 1 and incorporated herein by reference extending the Agreement for a period of one (1) year until March 31, 2021.

SECTION 2. This ordinance shall be in full force and effect on and after its passage and approval.

SECOND AMENDMENT TO THE FIRE PROTECTION AND LAW ENFORCEMENT SERVICES AGREEMENT

WHEREAS, the parties seek to extend the Agreement by a year; and

WHEREAS, this Second Amendment has been approved by the Mayor and a majority of the Board of Aldermen of Warson Woods and by the Mayor and a majority of the Board of Aldermen of Glendale.

NOW, THEREFORE, FOR THE CONSIDERATION SET FORTH HEREIN, WARSON WOODS AND GLENDALE AGREE AS FOLLOWS:

Paragraph 9 of the Agreement is hereby amended to read as follows:

9. This Agreement will become effective April 1, 2014, and shall continue in full force and effect for a period of seven (7) years from the 1st day of April, 2014, terminating at 11:59 P.M. March 31, 2021.
