AN ORDINANCE OF THE CITY OF WARSON WOODS, MISSOURI, ADOPTING AND ENACTING A NEW CHAPTER 215, OFFENSES, OF THE CODE OF ORDINANCES OF THE CITY OF WARSON WOODS, COUNTY OF ST. LOUIS, STATE OF MISSOURI; AND PROVIDING FOR THE REPEAL OF EXISTING CODE CHAPTER 215; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARSON WOODS, MISSOURI, AS FOLLOWS:

Section 1: Findings.

In the 2014 Legislative Session, the Missouri State Legislature enacted Senate Bill 491 and House Bill 1371 which resulted in numerous revisions to Title 38 (Crimes and Punishment) of the Revised Statutes of Missouri, effective as of January 1, 2017. Therefore, Chapter 215, Offenses, of the Code of Ordinances of the City of Warson Woods, County of St. Louis, State of Missouri, required substantial revision and re-adoption to effect compliance with the Revised Statutes of Missouri.

Section 2: Adoption of Revised Chapter and Repeal of Existing Provisions; Effective Date.

- A. The entirety of Chapter 215, Offenses, attached hereto as Exhibit A and incorporated herein by reference, is hereby adopted and enacted as Chapter 215 of the Municipal Code of the City of Warson Woods, Missouri; and such Chapter shall repeal and replace existing Code Chapter 215 as of the effective date provided in Subsection (C) hereof.
- B. The repeal of existing Chapter 215 set forth in Subsection (A) above shall not affect the following:
 - (1) Any ordinance adopted subsequent to September 15, 2015 which reflects the date of the last legislation reviewed for the most recent Code update (Supp #2, 9/15).
 - (2) Any offense or act committed or done or any penalty or forfeiture incurred or any contract or right established or accruing before the effective date of this ordinance, nor shall it affect any prosecution, suit or proceeding pending or any judgment rendered prior to such date.
- C. All provisions of this ordinance and revised Chapter 215, Offenses, adopted hereby shall be in full force and effect on January 1, 2017.

Section 3: Severability.

It is hereby declared to be the intention of the Board of Aldermen that the Sections, paragraphs, sentences, clauses and phrases of this ordinance and Chapter 215, Offenses, hereby adopted are severable, and if any phrase, clause, sentence, paragraph or Section of this ordinance or Chapter 215 hereby adopted shall be declared unconstitutional or otherwise invalid by the valid judgment or decree of a court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs and Sections of this ordinance or Chapter 215 hereby adopted.
