## AN ORDINANCE APPROPRIATING ADDITIONAL REVENUE AND AMENDING THE 2020 BUDGET FOR THE CITY OF WARSON WOODS

**WHEREAS**, the Board wishes to appropriate additional funds for salaries for certain full-time employees of the City and therefore amend the operating budget for the fiscal year 2019-2020; and

**WHEREAS**, the Board of Aldermen has the power and authority to revise budgeted income and expenditures from any fund pursuant to the provisions to Sections 67.030 and 67.040 RSMo.

## NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WARSON WOODS, MISSOURI, AS FOLLOWS:

**SECTION 1**. The Budget for the Fiscal Year 2019-2020 is hereby revised and amended to appropriate an additional \$2,786 to the budget to provide for a 2% wage increase over 2018-2019 salaries for full-time, non-step employees. The specific "Expenses" line items in the budget are hereby amended as set forth in Exhibit 1, attached.

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.
