**A RESOLUTION OF THE CITY OF WARSON WOODS,
MISSOURI, SUPPORTING THE HUDSON ELEMENTARY
SCHOOL PLAYGROUND PROJECT**

WHEREAS, the City of Warson Woods, Missouri (the “City”), is committed to fostering and promoting a safe, healthy, and beneficial learning environment for all residents of the City; and

WHEREAS, schools and parks and recreational facilities have the potential to create a dynamic, well-rounded, and self-sustaining community by providing vital community services; and

WHEREAS, modern and safe schools and parks and recreational facilities have profoundly positive impacts on the quality of life of students, staff members, families, and residents, and assist in attracting new residents and new businesses; and

WHEREAS, the City is committed to encouraging students to achieve their personal and academic goals in a joyful learning environment that promotes inclusivity, responsibility, and respect; and

WHEREAS, approximately three-quarters of the residents of the City are served by the Webster Groves School District, which includes Hudson Elementary School located in the City of Rock Hill, Missouri; and

WHEREAS, the current playground located at Hudson Elementary School is decaying and is in critical need of being rebuilt to provide for a safe, inclusive, and modern playground for children of varying abilities; and

WHEREAS, the Board of Aldermen of the City finds and determines that the proposed construction of a new playground at Hudson Elementary School (the “Hudson Elementary School Playground Project”) will improve and enhance the school and parks and recreational facilities for the benefit of the students, staff members, and families of Hudson Elementary School, as well as all residents and visitors of the City; and

WHEREAS, Board of Aldermen of the City deems it necessary and proper to support the proposed Hudson Elementary School Playground Project by joining the City of Rock Hill, Missouri, in a planning grant process and joint application for a Municipal Park Grant, to better serve the residents and visitors of the City and surrounding communities.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF WARSON WOODS, AS FOLLOWS:

SECTION 1. That the Board of Aldermen of the City of Warson Woods, Missouri, hereby expresses its support of, and joins with the City of Rock Hill, Missouri, in a planning grant process and joint application for a Municipal Park Grant for the proposed Hudson Elementary School Playground Project.

SECTION 2. This resolution shall be effective upon passage and approval.
