COURT ORDER

VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES
EFFECTIVE JUNE 1, 2019

Pursuant to 479.050, RSMO, Supreme Court Rule 37.495 and 38.09, the undersigned Municipal Judge of the City of Warson Woods hereby orders that the following designated offenses shall be payable to the City of Warson Woods Violations Bureau. In such cases, no court appearance is necessary.

In accordance with Missouri statutes and ordinances adopted by the City, total court cost shall be \$29.50. This includes Basic Court Costs of \$12.00, Crime Victim’s Compensation Surcharge of \$7.50, Judicial Information System of \$7.00, Law Enforcement Training Fund of \$2.00 and Peace Officer’s Standard Training Fund of \$1.00 ; for a total of \$29.50. Court costs have already been included in the fine schedule listed below.
